~~11.~~ 7. To select its presiding officers from the bishops, through a committee, provided that the bishops shall select from their own number the presiding officer of the opening session.

~~12.~~ ~~To change the number and the boundaries of jurisdictional conferences upon the consent of a majority of the annual conferences in each jurisdictional conference involved.~~

~~13.~~ 8. To establish such commissions for the general work of the Church as may be deemed advisable.

~~14.~~ 9. To secure the rights and privileges of membership in all agencies, programs, and institutions in The United Methodist Church regardless of race, gender, or status.

~~15.~~ 10. To allow the regional and annual conferences to utilize structures unique to their mission, other mandated structures notwithstanding.

~~16.~~ 11. To enact such other global legislation as may be necessary, subject to the limitations and restrictions of the Constitution of the Church.

Section IV. Regional Conferences

¶23 Article I

1. The United Methodist Church shall be comprised of four Global Regions: the Philippines, Africa, Eurasia, and the United States. The former Philippines Central Conference will become the Philippines Region. The former Central Conferences in Africa will become the Africa Region. The former Central Conferences in Europe and Asia will become the Eurasia Region. The former Jurisdictional Conferences in the United States will become the United States Region. Each Global Region will be comprised of two geographically overlapping but theologically defined Regional Conferences, provided that each regional Conference shall have a total of at least fifty clergy and fifty lay delegates, except as the General Conference may fix a different number.

a. The Global Regions shall be united by a Global Book of Discipline which affirms a distinct United Methodist history and heritage, basic Christian affirmations and our Wesleyan theology, as set out in Part III of the 2016 Book of Discipline.

b. Each Global Region shall have within its bounds two Regional Conferences, geographically overlapping and theologically distinct, each which shall affirm the unifying doctrinal standards contained

in the Global Book of Discipline.

(1) A Regional Conference, characterized by a commitment to the maintenance of the Church's historic expression of its doctrinal and moral standards.

(2) A Regional Conference, characterized by an acceptance of the evolving nature of the Church's expression of its historic doctrinal and moral standards.

c. Unity within the United Methodist Church shall be maintained by

(1) a covenantal acceptance and respect of each Regional Conference's distinct set of Social Principles

(2) Our affirmation of our unity in Jesus Christ as we live out the Gospel while acknowledging differences in applying and living our faith to different cultural contexts and global concerns including but not limited to: climate change, human sexuality, immigration, war and peace, and a myriad of other social, economical, and political concerns.

d. Membership in a Regional Conference shall not be determined by geography but by the formation, acceptance, and application of the distinct set of "historic" or "evolving" social principles adopted by each Regional Conference.

e. Each of these regional conferences is empowered to choose its own name and insignia, which may or may not include the use of the cross and flame and the name "United Methodist." When such names are chosen by a regional conference, the names in this Paragraph shall automatically be replaced with the new name without the need for additional constitutional amendment.

f. No regional conference shall adopt policies that are inconsistent with or violate ¶4 of the Constitution, either expressly or by practice.

2. Changes in the names and boundaries of the-overlapping regional conferences may be

determined by the Regional Conference upon the consent of a majority vote by two-thirds of the annual conferences of each of the regional conferences involved.

3. The number, names, and boundaries of the annual conferences and episcopal areas shall be determined by the regional conferences. The authority of regional conferences provided herein is not circumscribed or limited by the authority provided to the College of Bishops to arrange a plan of episcopal supervision.

4. Transfer of Local Churches—

a. A local church may be transferred from one annual conference to another in which it is geographically located upon approval by a two-thirds vote of those present and voting in each of the following:

i) the charge conference;

ii) the congregational meeting of the local church;

iii) each of the two annual conferences involved.

The vote shall be certified by the secretaries of the specified conferences or meetings to the bishops having supervision of the annual conferences involved, and upon their announcement of the required majorities the transfer shall immediately be effective.

b. The vote on approval of transfer shall be taken by each annual conference at its first session after the matter is submitted to it.

c. Transfers under the provisions of this article shall not be governed or restricted by other provisions of this Constitution relating to changes of boundaries of conferences.

Section IV. Regional Conferences

¶24. Article II. -

1. The regional conferences shall be composed of as many representatives from the annual conferences and missionary conferences as shall be determined by a uniform basis established by the General Conference, provided that no regional conference shall have fewer than 100 delegates. The delegates shall be clergy and lay in equal numbers. The missionary conferences shall be considered as annual conferences for the purpose of this article.
2. All regional conferences shall have the same status and the same privileges of action within the limits fixed by the Constitution. The ratio of representation of the annual conferences and missionary conferences in the General Conference shall be the same for all regional conferences.
3. The regional conferences shall meet within the year succeeding the meeting of the General Conference at such times and places as shall have been determined by the preceding respective regional conferences or by commissions appointed by them or by the regional College of Bishops.
4. The regional conferences shall have the following powers and duties and such others as may be conferred by the General Conferences:
 - a. To promote the evangelistic, educational, missionary, and benevolent interests of the

Church and to provide for interests and institutions within their boundaries.

b. To determine the number of bishops that may be elected, to elect bishops and to cooperate in carrying out plans for their support. Each regional conference shall provide the entire financial support for its bishops, including salary, housing, benefits, travel, and office expenses, unless supplemental funds are approved by the General Conference with the consent of the other regional conferences.

c. To establish and constitute regional conference boards as auxiliary to the general boards of the Church and to choose their representatives on the general boards in such manner as the regional conference may determine.

d. To determine the boundaries of their annual conferences, provided that there shall be no annual conference with a membership of fewer than fifty clergy in full connection, except by the consent of the General Conference.

e. To make rules and regulations for the administration of the work of the Church within the regional conference including changes and adaptations of the *Regional Book of Discipline* as the conditions in the respective regional conferences may require subject to such powers as have been or shall be vested in the General Conference and subject to the Constitution.

f. To appoint, if desired, a regional judicial court to determine legal questions arising on the rules, regulations, and such revised, adapted, or new sections of the *Regional Book of Discipline* enacted by the regional conference. There shall be a right of appeal of the decisions of regional judicial courts to the Judicial Council.

g. To appoint a committee on appeals to hear and determine the appeal of a traveling preacher of that regional conference from the decision of a trial committee.

h. To define and fix the powers and duties of district conferences, charge conferences, and congregational meetings.

i. To define and fix the conditions, privileges, and duties of Church membership, which shall in every case be without reference to race, gender, or status.

j. To define and fix the powers and duties of elders, deacons, supply preachers, local preachers, exhorters, deaconesses, and home missionaries, except as otherwise precluded by the Constitution, including ¶120.

k. To adopt a plan for the support of the bishops, to provide a uniform rule for their retirement, and to provide for the discontinuance of a bishop because of inefficiency or unacceptability, except as otherwise precluded by the Constitution, including ¶145.

l. To provide and revise the hymnal and ritual of the Church and to regulate all matters relating to the form and mode of worship, subject to the limitations of the first and second Restrictive Rules.

1 Article I.—There shall be a continuance of an episcopacy in The United Methodist Church of like plan, powers, privileges, and duties as now exist in The Methodist Church and in The Evangelical United Brethren Church in all those matters in which they agree and may be considered identical; and the differences between these historic episcopacies are deemed to be reconciled and harmonized by and in this Plan of Union and Constitution of The United Methodist Church and actions taken pursuant thereto so that a unified superintendency and episcopacy is hereby created and established of, in, and by those who now are and shall be bishops of The United Methodist Church; and the said episcopacy shall further have such powers, privileges, and duties as are herein set forth.

2. Article II.—The bishops shall be elected by the respective regional conferences and consecrated in the historic manner at such time and place as may be fixed by each regional conference provided that episcopal elections shall be held at a regular, not an extra, session of the regional conference, except in the case where an unexpected vacancy must be filled.

3. Article III.—There shall be a Colloquy of Bishops composed of all the bishops of The United Methodist Church. The Colloquy shall meet at least once a year and shall serve as a missional body that helps gather and distribute best practices for church vitality; is a learning, equipping, and nurturing community; acts as connectors to the jointly-shared ministries; guides the Wesleyan DNA emphases around justice, fairness, and inclusiveness, with special concern around our historic efforts to combat racism and sexism; handles Ecumenical relations; mediates accountability challenges; and ensures the carrying into effect of the rules, regulations, and responsibilities prescribed and enjoined by the General Conference.

4. Article IV.—The bishops of each regional conference shall constitute a College of Bishops, and such College of Bishops shall arrange the plan of episcopal supervision of the annual conferences, missionary conferences, and missions within their respective territories. Each college shall meet at least once a year and plan for the general oversight and promotion of the temporal and spiritual interests of the Church within their regional conference and for carrying into effect the rules, regulations, and responsibilities prescribed and enjoined by their regional conference. Each college shall also nurture and support its members and hold them accountable to the highest standards of United Methodist leadership and discipleship.

5. Article V.—The bishops shall have residential and presidential supervision in the regional conferences in which they are elected or to which they are transferred. Bishops may be transferred from one regional conference to another for presidential and residential supervision under the following conditions: (1) The transfer of bishops may be on either of two bases: (a) a regional conference that receives a bishop by transfer from another regional conference may transfer to that regional conference or to a third regional conference one of its own bishops eligible for transfer, so that the number transferred in by each regional conference shall be balanced by the number transferred out; or (b) a regional conference may receive a bishop from another regional conference and not transfer out

a member of its own College of Bishops. (2) No bishop shall be transferred unless that bishop shall have specifically consented. (3) No bishop shall be eligible for transfer unless the bishop shall have served one quadrennium in the regional conference that elected the bishop to the episcopacy. (4) All such transfers shall require the approval by a majority vote of the members present and voting of the regional conference committees on episcopacy of the regional conferences that are involved. After the above procedures have been followed, the transferring bishop shall become a member of the receiving College of Bishops and shall be subject to residential assignment by that regional conference.

A bishop may be assigned by the Colloquy of Bishops for presidential service or other temporary service in another regional conference than that which elected the bishop, provided that the request is made by a majority of the bishops in the regional conference of the proposed service.

In the case of an emergency in any regional conference through the death or disability of a bishop or other cause, the Colloquy of Bishops may assign a bishop from another regional conference to the work of the said regional conference, with the consent of a majority of the bishops of that regional conference.

6. Article VI.—The bishops, both active and retired, of The Evangelical United Brethren Church and of The Methodist Church at the time union was consummated shall remain bishops of The United Methodist Church.

The bishops of The Methodist Church elected by the jurisdictions, the active bishops of The Evangelical United Brethren Church at the time of union, and bishops elected prior to 2023 by the former jurisdictions of The United Methodist Church shall have life tenure. Each bishop elected by a former central conference of The Methodist Church prior to 2023 shall have such tenure as the former central conference electing him/her had determined. Bishops elected in 2023 or after shall have such tenure as the regional conference electing them shall determine.

The regional conference shall elect a standing committee on episcopacy to consist of one clergy

and one lay delegate from each annual conference, on nomination of the annual conference delegation. The committee shall review the work of the bishops, pass on their character and official administration, and report to the regional conference its findings for such action as the conference may deem appropriate within its constitutional warrant of power. The committee shall recommend the assignments of the bishops to their respective residences for final action by the regional conference.

These provisions shall not preclude the adoption by the General Conference of provisions for the Council of Bishops to hold its individual members accountable for their work, both as general superintendents and as presidents and residents in episcopal areas.

7. Article VII.—A bishop presiding over an annual, or regional conference shall decide all questions of law coming before the bishop in the regular business of a session, provided that such questions be presented in writing and that the decisions be recorded in the journal of the conference.

We can only receive the true unity Jesus offers as a gift, vision, and expectation as we trust him enough to step out in faith. Unity flowers through our relationship with one another in Jesus Christ. It is enriched as we work together in mission. It is deepened as we build relationships in spite of our real and significant

differences. To be sure, there are boundaries that must be maintained, which is why a common commitment to our Doctrinal Standards is an essential requirement for being Part of the United Methodist Church. But more than anything, unity is a project undertaken for the long haul by persons who are committed to the messy work of living out Jesus' imperative for unity.

As United Methodists, we accept that God's divine gift of reason present in human beings causes a multiplicity of thought. Those thoughts lead to a multiplicity of convictions. Historically, differing thoughts and convictions have led to divisions within both humanity and the Church. However, we affirm there are fundamental beliefs, doctrines, and confessions which draw humanity and the Church together. Therefore, The United Methodist Church is formed on a principle that a fundamental unity of doctrine can join a multiplicity of convictions. Furthermore, respect is the gift which unites the two.

¶103. Global Book of Discipline

The United Methodist Church is a worldwide denomination united by our Wesleyan way of serving Christ through doctrine, mission and the disciplined Christian life. The *Global Book of Discipline* expresses that unity as a connectional covenant.

Since the Global Book of Discipline is deemed to be global in nature it is not subject to regional change or adaptation except by action of the General Conference. The following parts and paragraphs constitute the Global Book of Discipline:

PREFACE

The United Methodist Church has a long history of concern for social justice. Its members have often taken forthright positions on controversial issues involving Christian principles. Early Methodists expressed their opposition to the slave trade, to smuggling, and to the cruel treatment of prisoners. A social creed was adopted by The Methodist Episcopal Church (North) in 1908. Within the next decade similar statements were adopted by The Methodist Episcopal Church, South, and by The Methodist Protestant Church.

The Evangelical United Brethren Church adopted a statement of social principles in 1946 at the time of the uniting of the United Brethren and The Evangelical Church. In 1972, four years after the uniting in 1968 of The Methodist Church and The Evangelical United Brethren Church,

the General Conference of The United Methodist Church adopted a new statement of Social Principles, which was revised in 1976 (and by each successive General Conference). With the restructure of the United Methodist Church by the 2020 Session of the General Conference, the authority to further define the Social Principles within theological and geographical ministry contexts was granted to the Regional Conferences.

They are a call to faithfulness and are intended to be instructive and persuasive in the best of the prophetic spirit. The Social Principles are a call to all members of The United Methodist Church to a prayerful, studied dialogue of faith and practice.

PREAMBLE

We, the people called United Methodists, affirm our faith in God our Creator and Father, in Jesus Christ our Savior, and in the Holy Spirit, our Guide and Guard. We acknowledge our complete dependence upon God in birth, in life, in death, and in life eternal. Secure in God's love, we affirm the goodness of life and confess our many sins against God's will for us as we find it in Jesus Christ.

We have not always been faithful stewards of all that has been committed to us by God the Creator. We have been reluctant followers of Jesus Christ in his mission to bring all persons into a community of love. Though called by the Holy Spirit to become new creatures in Christ, we have resisted the further call to become the people of God in our dealings with each other and the earth on which we live.

We affirm our unity in Jesus Christ while acknowledging differences in applying our faith in different cultural contexts as we live out the gospel. And while we honor our responsibility to define our witness and ministry by our historical foundations and evolving revelations; we recognize that in

respecting the differing theological and biblical interpretations of our brothers and sisters within the United Methodist family, we stand united in declaring our faith that God's grace is available to all, that nothing can separate us from the love of God in Christ Jesus. Grateful for God's forgiving love, in which we live and by which we are judged, and affirming our belief in the inestimable worth of each individual, we renew our commitment to become faithful witnesses to the gospel, not alone to the ends of earth, but also to the depths of our common life and work.

d. Transfer of a Local Church - A local church may be transferred from one annual conference to another, within or between Regional Conferences by a two-thirds vote of the professing members who

are present and voting in each of the following: (1) the charge conference, (2) a congregational meeting of the local church, and (3) each of the two annual conferences involved. Upon announcement of the required majorities by the bishop or bishops involved, the transfer shall immediately be effective. The votes required may originate in the local church or either of the annual conferences involved and shall be effective regardless of the order in which taken. In each case a two-thirds vote of those present and voting shall remain effective unless and until rescinded prior to the completion of the transfer by a vote of a majority of those present and voting.

2. ~~The Council Colloquy of Bishops and the colleges of bishops are is~~ thus the collegial expressions of episcopal leadership in the Church and through the Church into the world. ~~The Church expects the Council Colloquy of Bishops and the Colleges of Bishops to speak to the Church and from the Church to the world and to give leadership in the Christian unity and interreligious relationships.~~

3. In order to exercise meaningful leadership, the Council Colloquy of Bishops is to meet at stated intervals. The Council Colloquy of Bishops is charged with the oversight of the spiritual and temporal affairs of shared by the whole Church, to be executed in regularized consultation and cooperation with other councils and service agencies of the Church. The Colloquy of Bishops is a learning, equipping and nurturing community whose role is to gather and distribute best practices for church vitality; to act as a connector to the jointly-shared global ministries of the Church; to guide the Wesleyan DNA emphases around justice, fairness, and inclusiveness, with special concern around the elimination of racism and sexism; to develop and foster Ecumenical relations; to mediate accountability challenges; to ensure the proper administration of the rules, regulations, and responsibilities prescribed and enjoined by the General Conference.

4. The bishops of each regional conference shall constitute a College of Bishops, and such College of Bishops shall arrange the plan of episcopal supervision of the annual conferences, missionary conferences, and missions within their respective regions. Each college shall meet at least once a year and plan for the general oversight and promotion of the temporal and spiritual interests of the Church within their regional conference and for ensuring the proper administration of the rules, regulations, and responsibilities prescribed and enjoined by their regional conference. Each college shall also nurture

and support its members and hold them accountable to the highest standards of United Methodist leadership and discipleship.

2. *Timeline and Implementation:*
 - a. By **November 15, 2021** the Council of Bishops shall appoint a **Global Transition Team** to assist the Council of Bishops with developing and overseeing a transition process for the Global Church moving from the General Conference held in **2021** to the **2025** General Conference, working with existing groups and agencies where possible and appropriate. Its term of service shall expire as of **December 31, 2025**. Should the enabling constitutional amendments fail to receive the required majority vote of annual conference members, the Team's service shall immediately expire. The Team shall work with the Council and be amenable to the Council, with necessary funds to be provided by the General Council on Finance and Administration.
 - (1) The Team shall be composed of 32 persons chosen for skill and expertise, with an equal number from each of the four Global Regions. Within each Global Region there shall be equal representation between those committed to the Regional Conference characterized by a covenantal commitment to the Church's historic (traditional) expression of its doctrinal and moral standards and those committed to the Regional Conference characterized by a covenantal commitment to the Church's evolving (progressive) expression of its doctrinal and moral standards.
 - (2) The responsibilities of the Global Transition Team shall include, but not be limited to, the following:

i. to assist Regional Colleges of Bishops and Regional Transition Teams in designing the process for electing delegates to the 2023 organizing regional conferences (¶2801.1(e))

v. to write legislation, in conjunction with the various Regional Transition Teams, to be submitted to the 2025 General Conference for a Standing Committee on Regional Conferences to foster cooperation between the conferences, monitor compliance with efforts to combat racism and sexism, and deal with issues of conflict between the conferences

vi. to work with the General Council on Finance and Administration to handle legal, financial, and administrative changes, General Agencies to handle changes with general funds, and with Wespath to handle pension changes necessary in the transition.

vii. to develop a plan for dealing with the assets and liabilities of former jurisdictional and central conferences.

viii. to adapt the transition schedule provided in this Paragraph as needed.

ix. To develop a draft Global Book of Discipline incorporating all changes reflected in the Overlapping Regional Conference Plan as guided by ¶104 along with other changes needed to provide consistency through other Paragraphs.

X. In conjunction with the General Council on Finance and Administration and Colloquy of Bishops, to submit recommendations to the 2025 General Conference for the elimination of other references to the Connectional Table found in the Book of Discipline (¶¶263, 264, 427, 511, 606, 654, 703, 705, 713, 804, 807, 812, 819, 820, 821, 1207, 1310, 1403, 1421, 1636, 1703, 1804, 1806, 1807, 1808, 2001, 2201, 2301 in the *2016 Book of Discipline*) and any distribution of responsibilities as needed. In the interim, references to the Connectional Table in these Paragraphs will not be applicable.

xi. other responsibilities assigned by the Council of Bishops not in conflict with the Constitution or with the duties and responsibilities of Regional Transition Teams.

(3) As approved by the Council/Colloquy of Bishops, the Team shall have a project manager hired by and responsible to the Team and other paid staff or contracted services hired by and responsible to the project manager.

b. As soon as possible after the adjournment of the General Conference held in 2021, and no later than December 1, 2021, the General Conference secretary shall forward to the annual conferences the Constitutional amendments approved by the General Conference for the Overlapping Regional Conference Plan. Annual conferences shall be responsible to vote on ratification of these amendments by September 30, 2022, forwarding the results of this vote to the Council of Bishops immediately at the conclusion of the annual conference. Any annual conference that has not forwarded the results of its ratification ballot to the General Conference Secretary by October 21, 2022, shall be deemed not present and voting under ¶59. The ratification percentage for the amendments shall be counted based on the ballots received, and ballots not received shall not count as Part of the total. A

two-thirds affirmative vote is required for ratification. Upon certification by the Council of Bishops, results of the vote will be announced by **November 30, 2022**.

c. By **January 1, 2023** each active or retired bishop shall register with the president of the Colloquy of Bishops and the Global Transition Team with which regional conference he or she desires to affiliate.

d. By **February 1, 2023** each Regional Conference College of Bishops will meet to begin planning the new regional conference structure, in conjunction with the Global Transition Team. At their first meeting they will elect officers as needed from among their members. Each Regional College of Bishops shall appoint a **Regional Transition Team** to assist the Regional College of Bishops with developing and overseeing a plan for the formation of the regional conference.

(1) The number, composition and duration of the Team shall be determined by the Regional College of Bishops.

(2) The responsibilities of the Regional Transition Team shall include, but not be limited to, the following:

i. To develop a draft Regional Conference Book of Discipline incorporating all changes reflected in the Overlapping Regional Conference Plan as guided by ¶1104 along with other changes needed to provide consistency through other Paragraphs.

ii. to assist the Regional College of Bishops, in conjunction with the Global Transition Team, in designing the plan and process for electing delegates to the **2023** Constituting Regional Conferences (¶2801.1(e))

iii. to design and implement the **2023** Constituting Regional Conference.

iv. to ensure that candidates in the ministry process identified by the Global Transition Team process know how to transition into the new processes as designed by the regional conferences

v. to maintain an accurate and timely record of the annual conferences and local churches deciding to join the regional conference, in conjunction with the Global Transition Team.

vi. to work with the College of Bishops to develop the process for receiving and assigning clergy and transitioning churches who chose to join their regional conference from annual conferences outside their region.

vii. to work with the General Council on Finance and Administration to identify and handle legal, financial, and administrative changes necessary in the transition, including preparation of a draft Regional Conference budget and a funding plan.

viii. to work with the Global Transition Team or Colloquy of Bishops to address appropriate current global church responsibilities.

ix. to consult with the Global Transition Team in preparing legislation to be submitted to the **2025** General Conference for a Standing Committee on Regional Conferences to foster cooperation between the conferences, monitor compliance with efforts to combat racism and sexism, and deal with issues of conflict between the conferences.

x. To recommend to the **2023** Constituting Regional Conference an identifying name for the regional conference.

xi. other responsibilities assigned by the College of Bishops not in conflict with the Constitution or duties and responsibilities of the Global Transition Team.

e. The Constituting Conference of each regional conference shall take place between **September 1 - December 31, 2023** on a date and in a place set by each regional conference's College of

Bishops in consultation with the Global Transition Team and Regional Constituting Committee. Notwithstanding other provisions in the *Discipline*, materials proposed to be adopted by the organizing conference, including an *Interim* Regional Book of Discipline and nominations for an *interim* Executive Committee, shall be in the hands of the delegates no later than sixty (60) days prior to the date of the meeting.

f. Each annual conference shall meet by **July 1, 2024** to choose by simple majority vote of the delegates present and voting as to which of the two regional conferences in their Global Region they will join. All assets and liabilities owned by the annual conference shall belong to the regional conference with which that annual conference joins when the regional conference becomes effective. The decision of each annual conference shall be immediately communicated to the president of the Colloquy of Bishops and the Transition Team. After **July 1, 2028**, an annual conference may by a 60 percent majority vote of its members present and voting decide to switch its affiliation from one regional conference to another. Such a switch in affiliation shall require the majority approval of the receiving regional conference. An annual conference shall not consider a switch in its affiliation within less than four years from a previous vote on the question.

g. Between **July 1, 2024** and **October 1, 2024** any active or retired clergy person (ordained or licensed or in process) may register with his or her bishop and the Transition Team a desire to affiliate with a different regional conference than that chosen by his or her annual conference. Any clergy person not registering a choice shall by default remain a member of that person's annual conference and affiliate with the regional conference chosen by that annual conference.

h. Between **July 1, 2024**, and **December 1, 2024**, any local church that disagrees with the decision of its annual conference may vote to join a different regional conference by a simple majority vote of the church's professing members present and voting at a duly called regular or special church conference. The proposal to affiliate with a different regional conference shall originate either from the church council (or equivalent structure) or from a petition signed by a minimum of ten percent of the congregation's professing members. The bishop and Cabinet, along with other appropriate individuals of the annual conference, shall facilitate the orderly and timely administration of this process. The decision of each local congregation shall be immediately communicated to the president of the Colloquy of Bishops and the Transition Team. After **December 1, 2028**, any local congregation desiring to switch its affiliation from one regional conference to another shall follow the requirements of ¶41. A local church shall not consider a switch in its affiliation within less than four years from a previous church conference vote on the question.

i. After **January 1, 2025** each regional conference *interim* executive committee shall begin making interim assignments for bishops.

j. By **May 1, 2025** Regional Conferences will meet to redraw the boundaries of their annual conferences in order to encompass all their territory and congregations. Any new annual conferences formed shall have their organizing meeting on a date set by the regional conference college of bishops.

k. Between **May 1 - June 1, 2025** the Global Conference will meet.

3. Past and current pension and annuity liabilities under the Clergy Retirement Security Program shall remain the legal obligations of the annual conferences. Clergy affiliating with a different regional conference from their original annual conference shall have their associated past and current pension and annuity liabilities and related assets calculated, assigned and transferred as appropriate by the

General Board of Pension and Health Benefits to the annual/regional conference to which the clergy Participant transfers.

4. Clergy appointments taking effect **July 1, 2024**, shall be made as much as possible by matching the desired affiliation of clergy and congregation. Clergy credentials of ordination, commissioning, and licensing shall be recognized by all regional conferences and shall not be repeated, no matter which conference granted the credential, but the ability to serve in a Particular annual conference shall be determined by the qualifications and expectations set by that annual and regional conference.

a. Transitional Appointments. Clergy may make themselves temporarily available to serve in an annual conference/regional conference different from their preferred one, either by continuing a current appointment or in an interim appointment. In order to serve in an annual/ regional conference different from their preferred one, a clergy person shall agree to meet the qualifications of the different annual/regional conference and maintain the standards of conduct as set forth by the annual/regional conference they are serving. Failure to abide by this agreement shall constitute grounds for the bishop to revoke the appointment. Such transitional appointments are designed to be temporary until a place of service is found in the clergy person's preferred annual conference.

b. Service in Other Regional Conferences. Clergy persons may make themselves available to serve in more than one annual/regional conference. Such clergy person shall designate one annual conference for their primary conference membership. They shall indicate to their bishop a willingness to serve in other annual/regional conferences. In order to serve in an annual/regional conference different from the one where his or her membership is lodged, a clergy person shall agree to meet the qualifications of the different annual/regional conference and maintain the standards of conduct as set forth by the annual/regional conference they are serving. Failure to abide by this agreement shall constitute grounds for the bishop to revoke the appointment. Such a clergy person shall maintain membership in his or her designated annual/ regional conference, but shall be eligible for appointment to a different annual/regional conference with the approval of the receiving annual conference bishop and clergy session.

5. During the period **2020-2025**, the General Council on Finance and Administration and General Board of Global Ministries shall continue to facilitate and support the financial underwriting of bishops, annual conferences, and mission work outside the United States through the general apportionment and Advance giving

6. The general agencies shall continue in the structure and funding level established by the General Conference held in **2021** through **2025**, with the possibility of using reserve funds to supplement apportionments for those agencies not included in the *Global Book of Discipline* for the years **2021-2025**. Other general church funds shall be budgeted through the normal process for this period, with plans to accommodate the potential loss of apportionment income through the transition.

7. This Paragraph shall become effective immediately upon the close of the General Conference held in 2021.
